Annual General Meetings 2020 & 2021

Dear Member,

As you will be aware it was not possible to hold the AGM in 2020.

The Kennel Club has now agreed that the 2020 and the 2021 AGMs can be held consecutively and that they can be virtual meetings. Therefore, your committee has agreed that we will hold both meetings as virtual meetings. The 2020 Annual General Meeting of the Yorkshire Shetland Sheepdog Club will be held on Monday 31st May 2021 at 8pm followed by the 2021 AGM.

Items for the agenda and nominations must be with me by Monday 5th April 2021.

Items or matters cannot be discussed unless they have been placed on the agenda and must be proposed and seconded by members of the Club.

Nominations are invited for:

1. Vice Chairman: Mrs Bendelow has completed her three year term and seeks re-election for a three year term from 2020-2023.
2. Committee: Mrs Rowan, Mrs Tucker, Mrs Schofield and Mrs Dyson have completed their three year term. Mrs Rowan, Mrs Tucker, Mrs Dyson and Mrs Schofield seek re-election for a three year term from 2020-2023.
3. Chairman: Mr Goodwin has completed his three year term and seeks re-election for a three year term from 2021-2024.
4. Secretary: Mrs Bywater has completed her three year term and seeks re-election for a three year term from 2021-2024.
5. Committee: Mrs Walker, Mr Miles, and Mrs Kerry. As a co-opted member Mrs Froggett is now up for election. Mrs Walker, Mr Miles, and Mrs Kerry seek re-election for a three year term from 2021-2024. Mrs Froggett seeks election.
6. There are now THREE further vacancies and nominations are sought.

Please give this your serious consideration as we are short of committee members and this puts a strain on the rest of the committee.

Retiring officers and committee members seeking re-election are automatically nominated, as is Mrs Froggett, and do not require re-nomination.

All new nominations for Officer Position and Committee must bear a) the signature of the nominated member indicating their willingness to stand for election, b) the name, address and signature of the proposing member. Additionally, all nominations must bear the name, address and signature of a seconding member.

Nominations for officers must be a serving committee member and have served at least one three year term, save in exceptional circumstances.

Nominations for committee must have been a member of the Club for at least the previous three consecutive years.
